TECHNICAL SPECIFICATION OF ITEM (DP-5)

TENDER TERMS AND CONDITIONS FOR PROCUREMENT OF 21 X LINE SPARES FOR 02 X WX RADAR (VHDD 350C DP) BAF MTR & ZHR

Terms & Condition:

- 1. Offers are invited from the competent/ prospective bidders who are the manufacturer of the items or authorized representative of OEM for supply of 21 x L/I spares for 02 x Weather Radar (VHDD 350C DP) of BAF MTR & ZHR. Details of the items are given at Appendix 1 of Annex D.
- 2. Each item must be brand new, unused and latest product. Bidder should mention the year of production of each item in the offer.
- 3. Each item must be suitable and compatible to use in the VHDD 350C DP Weather Radar of BAF MTR and ZHR (manufactured by Baron Services inc. USA).
- 4. Bidder is to provide valid Government Assurance Certificate that there is no restriction from the respective Government to export the offered items.
- 5. Manufacturer's/ supplier's warranty/ guarantee certificates are to be submitted along with the items during shipment. Original Equipment Manufacturer's (OEM) Certificates are also to be provided with the items.
- 6. Any item having dissimilar part number or description is to be mentioned in the offer. In this regard proper certificate/ document must be enclosed with the offer. Any change in part number/ description must be settled before signing the contract. There will be no scope of changing the offered part number or description after signing the contract.
- 7. Delivery of the items is to be completed **within 300 days** from the date of signing the contract. However, longer delivery time may be accepted for the items requiring more time for production. Requirement of such delivery time/ situation must be mentioned in the offer. Final decision on acceptance of longer delivery time will be given by BAF.
- 8. Inspection of the supplied items will be carried out at buyer's premises in presence of the supplier or supplier's representative, unless they decline to do so.
- 9. Functional test of the items with the radar system must be carried out by OEM specialist. Supplier will forward the biodata and other details of OEM specialist during shipment of the items. BAF will arrange necessary security clearance of specialist.
- 10. The items will be accepted by BAF after prompt and satisfactory acceptance test in the Radar system.
- 11. If any item is found unsatisfactory/ unserviceable during functional check or within the warranty period, that must be replaced/ repaired free of cost by the supplier within 60 days from the date of reporting. Both ways Airfreight and Insurance charges for the unsatisfactory/ unserviceable item will be borne by the supplier.
- 12. Warranty period of each item shall be minimum 01-year from the date of satisfactory acceptance of the item by BAF.
- 13. If the supplier fails to repair/ replace an item/ equipment under warranty claim within the stipulated days as given above, then the warranty period would be extended by the number of days of delay in repairing/ replacing the item/ equipment under warranty.
- 14. DGDP/BAF reserves the right to increase/decrease the quantity of items and cancel the indent at any stages without assigning any reason.

Miscellaneous Terms & Conditions

- 15. The bidder must mention the full address including Telephone number, Fax number and e-mail address in the offer. The bidder also mentions the name and full address (including Telephone number, Fax number and e-mail address) of the local agent (if any) in the offer.
- 16. Item with changed/ dissimilar part no/ description (if any) is to be mentioned during submission of offer.
- 17. If any change is required in contract/ LC due to fault of supplier, all expenses shall have to be borne by the supplier.
- 18. Normally transshipment is not allowed. However, if the bidder needs transshipment they are to mention in the offer about their requirement. In case of such requirement, the transshipment may only be allowed under single AWB/BL.
- 19. The bidder is to mention the country of origin, country of manufacture and port of shipment of the items in the offer.
- 20. No increase of price at any stage after submission of offer will be accepted by BAF.
- 21. The bidder is to quote FCA/ FOB cost and freight charges (by both air and sea) separately & clearly in financial offer. Any price/ cost quoted in the pages of quotation other than financial offer will not be considered.
- 22. For failure to supply the contracted goods in time, DGDP/ BAF may cancel the contract with necessary punitive action.
- 23. Offer must remain valid till **30 June 2025** from the date of opening the tender. Within the validity of the offer, withdrawal of offer or unwillingness to sign the contract by the bidder will not be accepted and in such cases action would be taken against the principal supplier and local agent as per DGDP rules.
- 24. Delivery schedule mentioned in the tender specifications may be changed by DGDP/ BAF due to delay in concluding the contract. In this case, the contract would be signed within offer validity period. DGDP/ BAF also reserve the right to get the offer validity extended with the consent of the supplier.
- 25. Part shipment and part payment: Not allowed.
- 26. <u>Payment Terms</u>. 100% Payment in foreign currency (FC) will be made through an irrevocable Letter of Credit (LC) opened with scheduled bank in Bangladesh and negotiating bank recommended by the supplier under following terms and conditions:
 - a. 80% CFR/CPT value will be released on production of shipping documents to the bank.
 - b. Rest 20% CFR/CPT value will be released on satisfactory acceptance of 100% items by BAF after inspection/functional test (as applicable), on production of Certificate Receipt Voucher (CRV) and written clearance from DGDP.
- 27. AWB/BL must be in the name of consignee.
- 28. If any line item/item qty decreases then freight charge will be decreased proportionately.
- 29. Compliance of tender terms and conditions should be mentioned in the quotations by the bidders as per the above sequence.
- 30. Any other terms and conditions not covered here will be as per DGDP rules and regulations.
