The offered spare shall perfectly match with the said model of the equipment; but if does not match, it will have to be replaced at free of cost including freight charge.

c. The bidder is to quote the cost of each line item including number of units and unit price in clear terms. In case of partial order of quoted spare parts/ item(s), the total price will be calculated basing on number of units of each line item and unit price.

d. The bidder/ local supplier is not allowed to supply from local obtained off the shelf or locally manufactured/fabricated item.

If any defect/ discrepancy of any item arises within the period of warranty, the specific period from the date of notification of the defect/ discrepancy to the supplier up to the date of rectification of defect/ resolve of discrepancy will have to be deducted from the warranty period for that particular item(s).

b. If any defect/ discrepancy arises, within warranty period, then the respective item(s) is/ are to be replaced at free of cost including freight within 03 (three) months from the date of notification of the same to the supplier.
