1. Item. Valises Officer.
2. Quantity. 800 No's.
3. Brand. To be mentioned.
4. Model. To be mentioned.
5. Country of origin. To be mentioned.
6. Country of Manufacture. To be mentioned.
7. Source of Raw Materials. To be mentioned.
8. Name of Manufacturing Company & Address: Bidders have to mention the name of manufacturer & address of valise. If contact is given, the supplied item have to be of the same manufacturer. Relevant authenticity certificate/manufacturer's certificate must be submitted with the tender documents & supplied items.
9. Weight. 4.0 - 4.5 kg.
10. Material. Nylon.
11. Color. Black.
12. Dimension. (Excluding wheel attachment)
 - a. Length. 61 cm \pm 2 cm.
 - b. Breadth. 41 cm \pm 2 cm.
 - c. Height. 23 cm \pm 2 cm (Excluding 1 Chain extendable upto 4 cm).
13. Main Frame.
 - a. Length. (Inner) 59 cm \pm 2 cm..
 - b. Breadth. (Inner). 42.5 cm \pm 1 cm..
 - c. Height. 20 cm \pm 1 cm.
14. Wheel arrangement. To be mentioned.
15. Carrier. Aluminum handle with locking device-01.

21. **Design & Outlook.** Valise is to be spot free, defect free, smooth finish & workmanship.

22. **Shipment and Delivery**

25. **Packaging.** Each Valise is to be packed in a polythene packet individually and in a good quality carton.

26. **Marking.**


- a. **Valise.** A label must be attached with each valise containing inner side of valise following information:

- (1) Supplier's Name.
- (2) Production Month and Year.
- (3) Bangladesh Navy.

- b. **Carton.** Following marks are to be endorsed on each carton with indelible ink:

- (1) Name of Item.
- (2) Consignee.
- (3) Contract No. and date.
- (4) Supplier's address.
- (5) Endorsement of CINS as to inspection and acceptance (CINS will make endorsement after inspection).

27. **Delivery Schedule.** Supplier is to delivery items which are accepted by CINS. Valise are to be made as per contract sample (sample is for design and out look) and contract specification for material and manufacturing requirements and delivered at Supplier's cost and risk to consignee by the time and installment mentioned below.

28. **Warranty Certificate.** Supplier is to give warranty certificate on firm's letter head pad along with each consignment of valise which should clearly fulfill following requirements:

- a. 36 (Thirty six) months self life (from the date receipt by the consignee) against material and color i.e. color and material quality will remain unchanged for 36 months in normal storage condition. If the color becomes faded or material condition deteriorates or any defective item is detected at any time during the warranty period then supplier is to replace defective valise free of cost to the buyer.
- b. Warranty should be effective from the date of receipt by consignee.
- c. Contract number should be mentioned in the warranty certificate.

29. **Quality Assurance Certificate.** Quality assurance certificate in original from the manufacturer is to be given along with the consignment.

30. **Inspection by CINS.**


- a. CINS will inspect and test Valises at NSD Ctg as follows:
 - (1) Quality of material.
 - (2) Quantity .
 - (3) Design outlook.
 - (4) Dimension of Valise.
 - (5) Laboratory test (as required) to examine compatibility of material of Valise with tender specification.
- b. Supplier will bear following cost during inspection:
 - (1) Valise used for test, if needed.
 - (2) Laboratory testing charge, if any.
 - (3) Labour cost, if any.

31. **Inspection by Consignee.** Consignee will inspect the following at the time of delivery:

- a. Packaging
- b. Marking
- c. Quantity
- d. Warranty certificate
- e. Quality assurance certificate in original
- f. Endorsement of CINS as to inspection and acceptance.

32. **Supplier's Service and Responsiveness.** Supplier must reply to buyer's query within 03 days of raising the query.

34. **Liquidated Damage (LD).** LD will be applicable as per DGDP regulation.
35. **Sample Submission.** 04 (four) in number Valise Officer to be submitted as tender sample. Valise will be used for test. Supplier is to provide required quantity of item for lab test. Item quantity is taken for lab test is non refundable.
36. **Validity of Offer Required.** 180 days from the date of opening tender.
37. **Price Quotation.** Price is to be quoted in BDT as follows:
