## <u>SPECIFICATION OF ADULTICIDE PREMIX LIQUID INSECTICIDE (PERMETHRIN 0.5%, TETRAMETHRIN 0.2% & S-BIOALLETHRIN 0.1%)</u> (ADULTICIDE)

- 1. It should be safe for human being.
- 2. It should have 90% 100% adulticidal action on mosquitoes and flies when used at a concentration prescribed by the manufacturer.
- 3. It should not be toxic to beneficial insects, birds and domestic animals.
- 4. It should be readily broken down into non-toxic ingredients in the environment within a reasonable time period.

(2) Odor : Slight to pleasant

(3) Relative density : 0.79 - 0.83

(4) Content of active ingredients : Adulticide Premix Liquid

Insecticide (Permethrin 0.5%, Tetramethrin 0.2% & S-bioallethrin 0.1%) (Adulticide). Formulated with

suitable inert solvent.

(5) Water content/Moisture : Nil

(6) Chemical Stability : Should be stable under normal

storage condition.

(7) Solubility : Immiscible with water

(8) Boiling Point : >100° C

(9) Assay : The amount of each ingredient

should be within ±15% of the

declared content.

(10) Efficacy : Must kill 80% of the test insect

after 1 hour of application and 100%

after 24hours of application.

8. It will be tested in AFF&D Lab / IEDCR and field trialed by the medical authority of BAF for acceptance.

- 1. Item must be of latest products. Production date is to be mentioned in the offer.
- 2. Country of origin/manufacturer: should be mentioned by the bidder.
- 3. If the supplier is not the manufacturer necessary particulars (Name and address) of the manufacturer / formulator as well as assurance certificate from the manufacturer / formulator for supply of items / stores as per contract specs, terms and conditions is to be provided along with quotations. Registration No from plant protection wing, Khamar Bari, Farmgate, Dhaka is also to be mentioned in quotation.
- 4.
