- c. Overall Dimension. Not more than LxBxH = 620x500x610 mm. (Compact size is preferable).
- d. <u>Overall Weight</u>. To be mentioned. (Light weight is preferable for easy of transportation by 2 persons)
- e. <u>Mounting</u>. The engine and the pump should be mounted on a single base frame with resilient mountings. The complete unit should be easily portable. Base frame to be 2" cleared from the ground.
- 13. <u>Standard Accessories</u>. Standard accessories must include all items and accessories essential to operate each Portable Diesel Pump (including two pressure gauges, one for suction side and one for discharge side), whether mentioned in the specification or not. The price of standard accessories is to be included in the FOB value. However, an itemized price list of standard accessories are to be provided with the offer for reference value only.
- 14. Optional Items. The quotation should include a list of optional items (if any) required to operate each Portable Diesel Pump. When evaluating the comparative prices of the suppliers, only the prices of selected items by BN will be added to the total price.
- 15. <u>Tools</u>. 1 (one) set of standard tools for maintenance of each Portable Diesel Pump are to be provided. The price of standard tools will be included in the FOB value. However, itemised price lists of standard tools are to be provided with the offer for reference value only.
- 16. **Spare Parts.** A recommended list of spare parts required for maintaining each Portable Diesel Pumpare to be submitted with the quotation indicating the itemised price. That price will be added to the total price while evaluating the comparative price of the suppliers.

- 17. <u>Documents</u>. 02 (Two) sets of following documents in English language are to be supplied with the each Pump (free of cost):
 - a. Instruction Manual Including Technical Specification, Installation, Operation and Maintenance.
 - b. Spare Parts Catalogue and its Components.
 - c. Factory Test Certificate/Performance Certificate.
- 18. Quality Assurance Certificate. Quality assurance certificate in respect of the associated equipment in regards to its manufacturing and performance is to be provided at the time of delivery of the items.
- 19. <u>Test, trial and Acceptance</u>. Test and trial for the Portable Diesel Pumps will be carried out by the buyer in presence of the supplier's representative. After satisfactory test and trial, an acceptance certificate will be signed jointly by the supplier's representative and the representative of buyer.
- 20. <u>Warranty</u>. Warranty for trouble free operation is to be given by the principal/ manufacture for a period at least 12 months from the date of acceptance by the buyer. During the warranty period, if the equipment remains non-operational for any action pending by the supplier, the warranty period will be extended for the same period. The warranty covers all parts and labor (including service engineer's cost) throughout the warranty period.

21. Shipment.

- a. The supplier will arrange the shipment of all items by sea to Chittagong Port, Bangladesh.
- b. All items are to be delivered in sea-worthy packing to ensure safe transportation by sea.
- c. All packages must have detailed packing notes showing their contents, and they must be marked with the consignee's name, address, and gross weight.
- d. The supplier will arrange transportation of all supplied items from Chittagong port to the NSD Chattogram.
- e. <u>Port of Shipment</u>. Any port of the manufacturing country. In case of shipment through any port of the manufacturer's authorised dealer, the relevant manufacturer's certificate is to be provided as proof of the genuineness of the offered item.

22. Delivery.

- 23. Validity of Offer. The offer should remain valid till 180 days from the date of tender opening.



- 24. <u>Terms of Payment</u>. L/C for the full purchase amount will be opened in favor of the principal supplier under the following payment terms:
 - a. 80% of the total LC value will be paid on delivery of the goods described under the scope of supply and on production of necessary shipping documents.
 - b. The remaining 20% of the LC value will be paid upon producing an 'Acceptance Certificate' after a satisfactory test and trial jointly carried out by the buyer's and supplier's representatives.
- 25. <u>Condition for Acceptance of Quotation</u>. Quotation has to have supporting documents (booklets, leaflet, catalogue, brochure etc) having detailed particulars of the offered Portable Diesel Pump. If detailed information regarding specifications, maker's books and catalogues, spare parts, accessories, scope of supply, authentication certificate etc are not provided, the quotation will not be accepted.
- 26. <u>Compliance Statement.</u> A compliance statement fulfilling all the requirement of the tender is to be submitted for evaluation of the quotations. Stating mere 'Yes' or 'No' will not suffice and detailed description/ information as required is to be given. An incomplete compliance statement may attribute to cancellation of the offer. If any clause of this specification does not commensurate with the offered Portable Diesel Pump, the deviation has to be spelt out clearly.
