- 13. <u>Programming Kits/ License Software</u>. 04 (Four) sets of programming kit and 04 (Four) in no License Programming Software are to be provided for programming/cloning the VHF Transceiver (Walkie Talkie) and peripheral units.
- 14. <u>Scope of Supply</u>. The equipment is to be supplied fulfilling the technical specifications and complete in all respect with all required standard accessories and attachment (i.e Flexible antenna, Belt-Clip, Li-ion battery, Rapid charger with adapter and Genuine same brand spare battery etc.) which are required to obtain 100% performance of the sets whether it mentioned or not in the Specification. A list of offered standard accessories is to be attached separately with the quotation. In this regards the Bangladesh Navy (BN) reserve the right to reduce/ increase the quantity of item mentioned in the tender.
- 15. **Programming**. Upon receipt of the consignment at Naval Stores Depot Chattogram, the supplier's engineer is to programme all VHF transceiver (Walkie Talkie) at BN Dockyard with given frequencies in presence of BN reps. The supplier's engineer is to show BN reps the procedure of programming the sets so that BN can reconfigure/re programme the sets any time later if requires. Thereafter "Bench Test" to be conducted at BN Dockyard in presence of supplier's engineer.

#### 16. Acceptance.

- a. The supplier's engineer will show BN personnel routine operation and maintenance procedure. The supplier will provide additional materials required for full functioning of the set if otherwise not mentioned in this contract at free of cost (including freight and all other cost). If any equipment is found defective during initial test/trials, that/ those are to be replaced immediately by new ones. BN is to return the original defective equipment after receiving the replacements.
- b. On satisfactory completion of the test and trial, CINS/ BN will issue final acceptance certificate.
- 17. <u>Standard Accessories</u>. Standard accessories and assemblies have to be included (all items and accessories) which are essential to operate the equipment whether those are mentioned in the specification or not. Without quoted the concerned bidder will be considered disqualified supplier. A list of such items/ accessories/ assemblies with itemized price is to be included in the quotation as follows:

- 18. Manual. Following manual in English are to be provided free of cost at the time of delivery:
  - (1) <u>Operators Manual</u>. One set of original operators manual (covering major system units) is to be provided with each Walkie Talkie set.
  - (2) <u>Technical Manual</u>. Three sets of original technical/operating manuals (covering principle design and operations, detail circuit diagram, trouble shooting flowchart etc) for all supplied Walkie Talkie/accessories is to be provided.
  - (3) Workshop Level Repair Manual. Two sets of workshop level repair manual.
- 19. <u>Test and Trial</u>. Technically suitable bidders will have to submit 04 (four) sets of VHF Walkie Talkie with hand free headsets for test and trial to BN. The supplier is to submit the Walkie Talkie sets within 02 (two) weeks from the date of issuing letter. In this regards, one set of programming kit and software for programming/cloning, one set of original technical and operating manual (covering major system units) must be provided with the sample Walkie Talkie sets. Without test and trial concerned bidder will not be considered as qualified supplier. During test and trial following will be checked:

- 20. **Documents**. The following documents must be submitted with the offer:
  - (1) Certificate of assurance for minimum 10 years supply of spares.
  - (2) Itemized prices list of all spare parts that would be required within 05 years for repair/maintenance.
  - (3) Original brochure/ catalogue of the offered model of Walkie Talkie set.
  - (4) Manufacturer's/distributor's/agent's/dealer's certificate mentioning that the supplier (enlisted bidder) is being authorised for this quotation/offer and will be liable to fulfil all contractual obligation if the firm is awarded contract.
  - (5) Certificate of ingress protection standard IP (dust and water).
  - (6) Certificate of MIL-STD standard.

# 21. Warranty.

- a. Warranty for 02 (two) years trouble free operation of VHF Transceiver (Walkie Talkie) and its accessories wef the date of final acceptance by BN is to be provided by the principal/manufacturer.
- b. Warranty for 01 (one) year trouble free operation of Li-ion batteries wef the date of final acceptance by BN is to be provided by the principal/manufacturer.
- 22. **Extension of Warranty**. During the warranty period, if the item/equipment remains non-operational for any action pending by the supplier, the warranty period will be extended for the same period. The warranty covers all parts and labour (including service engineer's cost) throughout the warranty period.
- 23. <u>After Sales Service</u>. After sales service must be provided by the local agent within warranty period and thereafter as and when required (Assurance certificate to be submitted with the offer for at least 10 years).
- 24. **Price Quotation**. Marine Type VHF Transceiver (Walkie Talkie) and its accessories price is to be quoted in FC without VAT/ Tax etc as follows:
  - a. FOB price.
  - b. Freight.
- 25. **Port of Shipment**. Any port of country of origin/ manufacturer/ principal. It is to be mentioned in the offer.
- 26. <u>Delivery Destination</u>. The supplier will arrange delivery of all items to the NSD Chattogram. All sea/ air port formalities, customs clearance, transportation etc to be completed/ arranged by supplier. BN may be asked for necessary certificates/ documents.
- 27. **Delivery Schedule**. All items are to be supplied within 180 (one hundred eighty) days after issuance of purchase order by BN.
- 28. Validity of Offer. Offer should remain valid up to 30 Jun 2026.
- 29. <u>Consignee</u>. The Commanding Officer, Naval Stores Depot, Chattogram, New Mooring, Chattogram, Bangladesh/ Officer In-charge, Naval Stores Sub Depot Dhaka, Namapara Khilkhet, Dhaka 1229.
- 30. <u>Terms of Payment</u>. 80% of total CPT/ CFR value will be paid on completion of shipment of the contracted goods. Remaining 20% payment will be made on production of "Acceptance Certificate" rendered by BN (CINS) following successful test and trial upon delivery of items as per contract.

- 31. **Qualification of Bidders**. Only the genuine manufacturers or their authorized dealer can submit quotation through their authorized Dealer/Supplier enlisted at DGDP. In case of authorized dealer of OEM, manufacturer's certificate of authorization has to be submitted with the offer.
- 32. <u>Certificate and Document of Authentication</u>. The concerned supplier must provide following original certificate(s)/ document(s) as applicable with the quotation and during delivery of items as regard to the genuinity of source and item(s) in order to establish chain of links from the original source to supply of items:
  - a. One certificate by the Original Equipment Manufacturer (OEM) in favour of the supplier/local agent (in case of OEM as principal).
  - b. Two certificates, one by the OEM to authorized agent and other by the authorized agent to supplier/ local agent (in case of authorized agent as principal).
  - c. Three certificates, first one by OEM to authorized Dealer/Supplier, second one by authorized Dealer to sub- dealer and third one by sub- dealer to local supplier/ local dealer (in case of sub-dealer/supplier as authorized Dealer/Supplier). If the local supplier/ local dealer is unable to obtain the first certificate (by OEM to authorized Dealer/Supplier), then it has to produce relevant document to prove agency-ship of its claimed agent of the recognized manufacturer.
  - d. Quality Assurance Certificate (QAC) by the Original Equipment Manufacturer (OEM).
- 33. <u>Compliance Statement</u>. A compliance statement fulfilling all the requirement of the tender is to be submitted for evaluation of the quotations. An incomplete compliance statement may attribute to cancellation of the offer. If any clause of this specification does not commensurate with offered item, the deviation has to be spelt out clearly.
