- 1. Offers are invited from the competent/ prospective bidders those who are the manufacturer of Weather Radar (VHDD-350C DP) or authorized representative of OEM (M/S Baron Services Inc., USA) for mid-life calibration of 02 x Weather Radar of BAF MTR and BAF ZHR. For authorized representative, OEM/ Manufacturer's authorization certificate is to be submitted along with the offer. List of the item is shown in Appendix 1 of Annex D.
- 2. The bidder shall ensure that the mid-life calibration will not hamper the present operation status of radar. The mid-life calibration must cover all sub system of radar (Transmitter, Receiver, Antenna, Servo, Signal Processor Sub Systems, Display Terminal etc) and calibration is to be in accordance with required standards. The bidder is to submit the calibration checklist with the offer.
- 3. During mid-life calibration of radar, following additional fault and recurring software issues (but not limited to) are required to be resolved:

- 6. The bidder shall resolve calibration and software updates related issues through online for next 12-month after satisfactory acceptance at free of cost. In this regard, the bidder shall mention a point of contract of OEM specialist in the offer.

- 2. Item with changed/ dissimilar part no/ description (if any) is to be mentioned during submission of offer.
- 3. If any change is required in contract/ LC due to fault of supplier, all expenses shall have to be borne by the supplier.
- 4. Normally transshipment is not allowed. However, if the bidder needs transshipment they are to mention in the offer about their requirement. In case of such requirement, the transshipment may only be allowed under single AWB/BL.
