TENDER SPECIFICATION OF RIFLE MAGAZINE POUCH FOR 5.56 MM M-4 CARBINE, UTILITY POUCH, FLASH BANG POUCH, SMOKE GRENADE POUCH, RADIO POUCH AND TOURNIQUET POUCH (QTY: 06 L/I)

1. **Name of Items.** The name of the items are as follows:

- a. Rifle Magazine Pouch for 5.56 mm M-4 Carbine.
- b. Utility Pouch.
- c. Flash Bang Pouch.
- d. Smoke Grenade Pouch.
- e. Radio Pouch.
- f. Tourniquet Pouch.

2. **Purpose.**

- a. Rifle Magazine Pouch for 5.56 mm will be used to carry 5.56 mm Carbine Magazine.
- b. Utility Pouches are used to add with any tactical vest, allowing to carry a wide selection of equipment, small tools, torch light, hand GPS, NVD etc.
- c. Flash Bang Pouch are used with tactical vest, allowing to carry Flash Bang (Stun Grenade) to have access when it is required in operation.
- d. Smoke Grenade Pouch are used to add with any tactical vest, allowing to carry Smoke Grenade (40 mm Grenade) and have access when it is required in operation.
- e. The Radio Pouch ensures comfortable and secure carrying of radio devices.
- f. Tourniquet Pouch is used to securely carry and provide quick access to tourniquet, especially in emergency or tactical situations.

8. **Manufacturing Country.** Argentina, Australia, Austria, Brazil, Belgium, Canada, Denmark, France, Finland, Germany, Greece, Italy, Indonesia, Japan, Norway, Netherlands, Poland, Serbia, South Korea, Spain, Sweden, Turkiye, UAE, UK and USA.

9. **Supplier/Principal.** Name and full address with e-mail of supplier/principal are to be mentioned.

10. **Local Agent.** Name and full address with e-mail of supplier/principal are to be mentioned.

11. **Qualification of Bidder.**

a. Only an Original Manufacturer (The Manufacturer), or an authorized dealer on their behalf, can submit quotation through an authorized agent (i.e. the Bidder) in Bangladesh. Offers from multiple manufactures may be allowed through such an authorized agent in Bangladesh.

b. **Certificate/Document of Authentication.** The Bidder must provide following original certificate(s)/document(s) with the offer to authenticate genuineness of source and item(s) in order to establish chain of links from the original Manufacturer to the Bidder:

(1) 01 (One) in number certificate/document by the Manufacturer in favour of the Bidder (In case the Manufacturer is the Direct Source).

(2) 02 (Two) in number certificates/documents, 1st one by the Manufacturer to Authorized Agent and 2nd one by the Authorized Agent to the Bidder (In case the Manufacturer's Authorized Agent/ Seller is the Immediate Source).

(3) 03 (Three) in number certificates/documents, 1st one by the Manufacturer to Authorized Agent/Dealer, 2nd one by the Authorized Agent to Sub-Agent/ Seller and 3rd one by the Sub-Agent/Seller to the Bidder (In case the Sub-Agent/ Seller is the Immediate Source).

c. **Export License.** Obtaining 'Export License' for the sale of Rifle Magazine Pouch for 5.56 mm M-4 Carbine, Utility Pouch, Flash Bang Pouch, Smoke Grenade Pouch, Radio Pouch and Tourniquet Pouch (Qty: 06 L/I) will be the responsibility of the Bidder (BN will provide 'End User Certificate'). The Bidder must mention this clearly in offer- except which the offer will be deemed incomplete and disqualified.

12. **Scope of Supply.**

a. Rifle Magazine Pouch for 5.56 mm M-4 Carbine (Qty: 400 in nos), Utility Pouch (Qty: 100 in nos), Flash Bang Pouch (Qty: 200 in nos), Smoke Grenade Pouch (Qty: 100 in nos), Radio Pouch (Qty: 100 in nos) and Tourniquet Pouch (Qty: 300 in nos), (as per para 13 to 18).

b. Test/ Trail and Acceptance (as per para 28).

c. Documentations (as per para 23).

13. **Description of Items.**

a. **Rifle Magazine Pouch for 5.56 mm M-4 Carbine.** It is designed to hold 5.56 mm M-4 Carbine magazines in one convenient modular attachment. This allows to the pouch to be securely fixed to Tactical Vest/ Body Armor Plate Carrier.

b. **Utility Pouch.**

(1) It is a compact, durable and versatile storage solution designed for a wide range of applications.

(2) It offers superior resistance to abrasion, moisture and harsh environmental conditions.

c. **Flash Bang Pouch.**

- (1) It is designed for rapid access and secure retention of grenade (at least two) or similarly sized gear.
- (2) It ensures reliability in extreme environments.

d. **Smoke Grenade Pouch.**

- (1) It is designed for one handed use, allowing fast deployment in critical situations.
- (2) Used for secure storage of standard Smoke Grenade (at least one).
- (3) Easily attaches to tactical vests, belts or packs for seamless integration.

e. **Radio Pouch.** It is designed to securely hold and protect a portable two-way radio (Walkie-Talkie) or communication device.

f. **Tourniquet Pouch.** It is a compact, durable pouch designed to securely hold a tourniquet (A medical device used to stop severe bleeding).

14. **Characteristics of Items.**

a. **Characteristics of Rifle Magazine Pouch for 5.56 mm M-4 Carbine.**

- (1) 5.56 mm Magazine Pouch compatible with open top bungee-retention and adjustable flap.
- (2) Fits three mag pouches.
- (3) Attachment straps are for easily attaching pouch to other gear.

b. **Characteristics of Utility Pouch.**

- (1) Carries small medical gear, gauze and other multi tools.
- (2) Useful for quick access to small emergency item.
- (3) Attachment straps are for easily attaching with belt or other gear.
- (4) Fits one Utility Pouch standard size with tactical vest/belt.

c. **Characteristics of Flash Bang Pouch.**

- (1) Velcro flap, buckle or shock cord retention to secure Grenade.
- (2) Secure hold to prevent grenade movement or accidental release.
- (3) Compatible for integration with tactical vests, belts or other gear.
- (4) Fits 02 (Two) Flash Bang Pouch standard size with tactical vest/belt.

d. **Characteristics of Smoke Grenade Pouch.**

- (1) Velcro flap, buckle or bungee cord with pull tab for secure fit and fast draw.
- (2) Fits one mag pouch.
- (3) Attachment straps for easily attaching with tactical vests, belts or other gear.
- (4) Fits one Smoke Grenade Pouch standard size with tactical vest/belt.

e. **Characteristics of Radio Pouch.**

- (1) Universal size for different radio models.
- (2) Water and shock resistance.
- (3) Adjustable straps or elastic cords and quick release buckles or Velcro.

f. **Characteristics of Tourniquet Pouch.**

- (1) Fast and single handed access.
- (2) Velcro closure, elastic retention or quick pull tab.
- (3) Fits one Tourniquet Pouch standard size with tactical vest/belt.

18. **Shelf Life.** Shelf Life is to be 10 (Ten) years from year of manufacture. 'Shelf Life Certificate' from manufacturer is to be provided with the offer.

19. **Manufacturer's Certificate.** A Certificate from the manufacturer is to be provided, stating that the items offered are original, brand new, unused and produced in the year 2026 or later. It is also to be certified that the offered items will comply the technical specification mentioned in Para 2, 13 to 17.

20. **Sample.**

a. 03 (Three) in number's sample of each Items mentioned in Para-1 (Might be from ready stock) are to be submitted along with the offer for evaluation of tender.

b. In addition the Successful Bidder is to submit a prototype complete package {(As per Para-1 and on the basis of BN provided sample pictures (Annex-A))}, to the Buyer within 30 (Thirty) Days of contract. Final production of the item might only be undertaken after formal approval by BN of such samples.

21. **Packing Details.** All items to be packed in hermetically sealed condition and with standard sea-worthy packing. Material and size of items box, numbers of items per box, weight per box etc are to be mentioned in the offer. Each package is to be marked as follows:

22. **Brochure/ Catalogue.** 01 (One) copy of original brochure/ catalogue for each item (In English) is to be provided with the offers for evaluation of tender. Product brochures of the manufacturer are to be provided along with the offers.

23. **Manual.** 02 (Two) sets of Maintenance and Storage Manual in English are to be provided with the Stores.

24. **Warranty.**

a. Minimum 12 (Twelve) months warranty from the date of Final Acceptance by the buyer for trouble free use is to be provided by the manufacturer. If any defect/discrepancy arises in any supplied item(s)/component(s) within the warranty period, the warranty period for the relevant item(s)/component(s) shall be automatically extended by the specific duration from the date of notification to the supplier until the date of rectification of the defect or resolution of the discrepancy.

b. If any defect/discrepancy arises within the warranty period, the item(s)/component(s) are to be replaced free of cost, including freight, within 03 (Three) months from the date of notification to the supplier. In this regard, the supplier must furnish an undertaking with the offer stating, **"We do hereby assure that we take the liability to replace all item(s)/component(s) free of cost, including freight, within 03 (three) months from the date of notification about the defect/discrepancy of the item(s)/component(s) by the buyer, if it occurs within the period of warranty."** For warranty replacement, the supplier will collect the defective item(s) from NSD Chattogram and re-supply the same to the collecting place.

c. A 'Warranty Certificate' must be submitted with the offer.

25. **Guarantee.** Guarantee is to be given that the each item will be suitable to meet the purpose mentioned in Para-2, 13-18 and the performance of the items will remain effective in all respect for the period of shelf life. Certificates are to be provided with the offer.

26. **Quality Assurance.** A Defence Quality Assurance Certificate must be provided by the appropriate Quality Assurance Organization of the manufacturing country.

27. **Undertaking.** If the supplied items are found unsuitable for use by the Bangladesh Navy, the same are to be taken back by the supplier and replaced at no cost to the Bangladesh Navy.

28. **Final Acceptance.** Upon the delivery of the items mentioned in Para-1, a joint inspection will be conducted by Naval Armament Inspection Organization (NAIO), Chattogram in presence of the Supplier's representatives. Final Acceptance of the item will be given by Naval Armament Inspection Organization (NAIO), Chattogram after physical inspection and comparing supplied items with approved sample. After Final Acceptance a certificate will be signed by both supplier and BN representatives.

29. **Shipment and Delivery.**

a. **Place of Delivery.** The supplier will arrange delivery of all the items to the following address:







- b. The supplier will transport the items from Seaport/ Airport at Chattogram/ Dhaka to NSD, Chattogram under their own arrangements and shall bear all related costs and risks.
- c. **Delivery Schedule.** Item is to be delivered within **120 days** from the date of signing of the Contract.
- d. **Port of Shipment.** Port of shipment will be in manufacturing country.
- e. **Source of Supply.** The source of supply, whether from country of manufacturer or country of origin, to be mentioned with detail address, e-mail & contact number.
- f. **Source of Raw Materials.** To be mentioned with detail address of source, e-mail & contact number.
30. **User's List.** List of users (Country/ Agency/ Organization) indicating year is to be mentioned.
31. **Price.** If the item is imported against this tender, price to be quoted **without import duties.**
32. **Terms of Payment.** Total (100%) payment will be made in local currency after satisfactory test/trial and final acceptance by the Bangladesh Navy.
33. **Validity of Offer.** 30 June 2026.
34. **Compliance Statement.** A compliance statement containing all the required information is to be submitted with the offer for tender evaluation. Any deviation from the specification is also to be clearly stated in the offer. Mere mentioning of "Yes/No" or "Comply" will not be sufficient; detailed technical data and information of the offered item are to be provided. An incomplete compliance statement may attribute to cancellation of the offer.
