

28. **Special Requirements:**

- a) Enzyme treatment to remove the hairiness.
- b) "Enzyme silicon" wash basic fabrics must be use for T-Shirt.
- c) Hand feel of fabrics must be soft and smooth.
- d) All T-Shirt must be free from all kinds of naps, slubs, knitting fault, stitich and dyeing/printing fault.
- e) Use double row Flat lock stitch for Neck binding, under length binding, sleeve binding and solder stitch.
- f) Use over lock stitch for both side of under arm, under sleeve and both joint.

29. **Packaging.** Each T-Shirt fold and packed in an adhesive poly bag. Silica gel packet should be given with each poly bag. 100 pieces T-Shirt packed in a proper paper carton.

30. **Marking (T-Shirt).** Bangladesh NAVY & Size will be print with T-Shirt. Manufacturer name with care label will attached inside of joint stitch (10 cm upper from under length binding).

a. **Marking (Carton).** Following marks are to be printed on one side of each carton:

- (1) Supplier's name.
- (2) Supplier's address.
- (3) Item Name.
- (4) Quantity in each Carton.
- (5) Production month and year.
- (6) Contract/purchase order no.

b. **Marking (Carton).** Following marks are to be printed on another side of each carton:

- (1) Bangladesh Navy.
- (2) Consignee's address.



31. Delivery

Place of Delivery. The supplier will arrange shipment of the item to Chatto. Consignee address is as follows:

33. Warranty. Supplier is to give warranty certificate Inner Vest (Digital Combat T-Shirt) which should clearly fulfill following requirements:

- 24 (Twenty Four) months self life (from the date of acceptance) against material and color i.e. color and material quality will remain unchanged for 24 (Twenty Four) months in normal storage condition. If the color becomes faded or material condition deteriorates or any defective item is detected at any time during the warranty period then supplier is to replace defective vest free of cost to the buyer.

34. Quality Assurance Certificate. Quality assurance certificate from the manufacturer is to be given along with the consignment.

35. Inspection by CINS.

a. CINS will inspect Inner Vest (T-Shirt Combat) at factory premise as follows:

- Quality of material.
- Quantity.
- Design and outlook.
- Laboratory test (as required) to examine compatibility of material of Fabric with contract specification.

b. Supplier will bear following cost during inspection:

- Fabric used for test.
- Laboratory testing charge, if any.
- Labor cost, if any.

36. Inspection by Consignee. At the time of delivery consignee will inspect the following:

- Packaging.
- Marking.
- Quantity.
- Warranty certificate.
- Quality assurance certificate.
- Endorsement of CINS as to inspection and acceptance.



Other Required Information for Bidders

37. **Evaluation of Offer(s)**. For the purpose of acceptance, tender offer will be evaluated on the basis of following:

- a. Washing test.
- b. Rubbing test.
- c. Calendering/ironing after washing.
- d. Material test in laboratory (as required) to examine compatibility of material of supplier's sample with specification.
- e. Color fastness.
- f. Price.

38. **Supplier's Service and Responsiveness**. Supplier must reply to buyer's query within 03 days of raising the query.

39. **Payment**. Payment will be made in BDT as per DGDP regulations.

40. **Liquidated Damage (LD)**. LD will be applicable as per DGDP regulations.

41. **Sample Submission**. Bidder is to submit 05 in no (Large sizes) inner vest and 2 meter fabric along with tender offer as sample. Vest will be used for test. Supplier is to provide required quantity of item for lab test. Item quantity is taken for lab test is non-refundable. If Supplier fail to submit above mention size than sample will be rejected.
