Packaging After Inspection and Stamping, each Beret to be packed in a polythene bag containing one naphthalene ball of $\frac{3}{4}$ " x $\frac{5}{8}$ " size. Such 10 Nos Berets will be tied with twine ball to make a bundle Such 20 bundles (20 x 10 = 200 Nos) will be packed in a 7 Ply corrugated caper carton of proper size with securing two poly band strap (width wise).

<u>Drop Test</u>. Carton used for packing should be of high quality. The carton should not fail in drop test with required no of products in it. Drop test to be done from two meters height thrice in any direction

Condition of Test. If any sample (Tender, Advance & BR can not be tested by IGS&C then those should be tested at any internationally reputed laboratory in Bangladesh. The supplier should pay test cost as per DP-35 sub para-12(A&B).

Quality Control Certificate/Quality Inspection by Supplier.

- Supplier has to provide a certificate (along with all challan) that they have carried out a comprehensive quality inspection at their end and they are fully confirmed and satisfied about the following:
 - Products are produced/manufactured as per specification.
 - Products are tested/inspected as per the specified testing mentioned in this specification and found correct.
- Supplier must also provide fabric (basic cloth) test report. Fabric (basic cloth) to be tested from any internationally reputed laboratory.
- The warranty/guarantee period of the store will be 16 (Sixteen) Warranty/Guarantee. 10. months from the issue of Inspection Note by IGS&C. In this regard the Manufacturer/Supplier should provide a warranty/guarantee certificate regarding durability of the supplied stores. If the supplied stores found defective within 16 (Sixteen) months during storage or 03 (Three) months of intended practical use (Under normal use with standard maintenance) then the defective stores should be replaced by the manufacturer/supplier at their own cost within 30 (Thirty) days at COD Dhaka Cantt as the case arises.
- Advance Sample & Bulk Representative (BR) Sample. Sample should be submitted at free of cost for Lab & Visual test (As per sub para-12 d(ii) & 12c(i & ii) of DP-35).

Notes:

- a The Beret should be knitted in one piece.
- Shade will be as per requirement and approved sample held in IGS&C.
- There should be an agreement between supplier and manufacturer where supplier will produce product from a specific factory (Maximum three factories can be nominated by the supplier to avoid unforeseen situation for which the primarily selected manufacturer or factory owner by the supplier might not be able to run the factory/machineries, i.e natural disaster, unavoidable mechanical failure of machines etc) and submit with tender. Later on the supplier will produce 100% product from the same factory. The supplier must submit one copy of this agreement initially to DGDP. The supplier will submit the final agreement on stamp between supplier and manufacturer to DGDP while contract is being processed with DGDP.




