TENDER SPECIFICATION: BELT WAIST BLUE

Specifying Item and Quantity

1. **Name of Item.** Belt Waist Blue
2. **Color:** Navy Blue (As per Sample).
3. **Quantity:** 40,000 Nos
4. **Country of Manufacturing.** To be mentioned.
5. **Source of Raw Materials:** To be mentioned.
6. **Design and Outlook:** Belts must have clear and fine finishing and free from any kind of defect.
7. **Material of Belt:** Polyester/ Nylon/ Polyamide
8. **Length of Belt:** 1250 mm ~ 1280 mm.
9. **Width of Belt:** 35 ± 1 mm.
10. **Thickness of Belt:** 2.45 mm, -2.60 mm.
11. **Weight:** 100 gm ± 5gm (Polyester)/ 80 gm ± 5gm (Nylon/ Polyamide)

Delivery Requirements

12. **Packaging.**
 - a. Belt waist Blue is to be supplied in a transparent polythene packet.
 - b. 200 Belts Navy Blue are to be packed separately in good quality carton.
13. **Marking.**
 - a. **Carton.** Following marks are to be endorsed on each carton with indelible ink:
 - (1) Name of Item.
 - (2) Consignee.
 - (3) Contract No. and date.
 - (4) Supplier's address.
 - (5) Quantity in each carton.
 - (6) Endorsement by CINS as to inspection (CINS will make endorsement after inspection).
14. **Shipment and Delivery**

Place of Delivery. The supplier will arrange shipment of the item to Chattogram without import duties. Consignee address is as follows:

New Mooring, Chattogram, Bangladesh

Country of Shipment: Any port of manufacturing country.

15. **Delivery Schedule.** Belt are to be delivered at supplier's cost and risk to consignee as per following delivery schedule:

Consignee	Installments	Delivery time after signing the work order	Quantity (No)

16. **Warranty Certificate.** Supplier is to give warranty certificate along with the consignment which should clearly fulfill following requirements:

a. 18 (Eighteen) months shelf life (from the date of acceptance) against material and colour. i.e. colour and material quality will remain unchanged for 18 months in normal storage condition. If the colour becomes faded or material condition deteriorates or any defective item is detected at any time during the warranty period then supplier is to replace defective belt free of cost to the buyer.

b. Contract number should be mentioned in the certificate.

17. **Factory /Manufacturer Certificate:** Relevant "Factory/Manufacturer certificate" is to be submitted during delivery of items.

18. **Quality Assurance Certificate (QAC).** Supplier is to obtain QAC from the manufacturer and submit along with the consignments.

19. **Inspection by CINS.**

a. CINS will inspect and test belt at NSD Ctg as follows:

- (1) Quality
- (2) Quantity
- (3) Design & outlook.
- (4) Dimension
- (5) Laboratory test (as required) to examine compatibility of material of belt with tender specification.

b. Supplier will bear following cost during inspection:

- (1) Belt used for test, if needed.
- (2) Laboratory testing charge, if any.
- (3) Labour cost, if any.

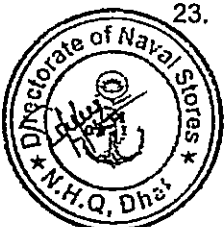
20. **Inspection by Consignee.** At the time of delivery consignee will inspect following:

- a. Packaging.
- b. Marking.
- c. Warranty certificate.
- d. Quality assurance certificate.
- e. Endorsement of CINS as to inspection and acceptance.

21. **Supplier Service and Responsiveness.** Supplier must reply to buyer's query within 03 days of raising the query.

22. **Payment.** Payment will be made in BDT as per DGDP regulations.

23. **Liquidated Damage (LD).** LD will be applicable as per DGDP regulations.

24. **Sample Submission.**

- a. Bidder is to submit 04 in number belt waist blue along with tender offer as sample. Belt waist blue will be used for test and non- returnable.
- b. Supplier must provide the certificate for the manufacturer that the sample submitted is produced by the manufacturer in their own factory. They will supply the ordered item from the same manufacturer who produced the sample.

25. **Validity of Offer Required.** Tender offer must be valid for 180 days from the date opening tender.

26. **Price Quotation.** Separate price is to be quoted with & without import duties. Price is to be quoted in BDT as follows:

27. **Compliance.** A compliance statement fulfilling all the requirement of the tender is to be submitted for evaluation of the quotations. Stating mere Yes or No will not suffice and detailed description/information as required is to be given. An incomplete compliance statement may attribute to cancellation of the offer. If any clause of this specification does not commensurate with offered belt waist blue. The deviation has to be spelt out clearly.
