# **REVISED ASC SPECIFICATION NO. 54(A)**

### **DAL MOONG**

1. Quality. Dal Moong Shall consist of the split seeds of the green lentil (Phaseolus mungo). It shall be in the from of split, bean-shaped seeds, of light green colour, dry and hard. The dal shall be of the current season's crop and shall be sound, dry, sweet, clean and wholesome.

Dal Moong damaged by insects, moulds, other infections, foreign grains and other impurities shall not exceed the proportion indicated in para 5 below.

The dal shall be of one variety and shall have good cooking quality.

- 2. Packing. Dal Moong shall be packed in contractor's non-returnable packs. Dal Moong to be supplied in polyethylene bags and shall be heat sealed at both ends. Material for the packing must be made of such material which does not affect quality and ingredients of Dal Moong. Each polyethylene bag shall contains 05 kg/01 kg/500 gm net Dal Moong. The plastic bag shall be secured in 25 kg Nylon woven bags. Each of woven nylon bags will be of 75 cm(+/-10cm) × 60 cm (+/-10 cm). Mouth of the woven bags. Each of woven nylon bags will be of 75 cm (+/-10 cm) 60 cm (+/-10 cm). Mouth of the nylon woven bags shall be secured with machine stitch. Mouth of the nylon woven bag shall be stitched as such so that 10 cm space is kept on the mouth of the bags. Ratio of 05 kg/01 kg/500 gm kg plastic bags is 40%, 40% and 20% respectively or as specified in the final contract subject to be confirmed from the user/indentor.
- 3. Marking. The bag shall be stenciled on one side as follows:
  - a. Dal Moong (in 3 inch characters).
  - b. Net weight.
  - c. Gross weight
  - d. Date of packing.
- 4. <u>Hygiene.</u> The dal shall be cleaned and bagged in premises maintained in hygienic condition which shall be open to inspection at any time by a competent authority approved by the Director-General, Medical Services. The basic hygiene requirements in a factory supplying products for the Defence Services shall be as stated in Appendix II to these specifications.

In addition all machinery together with the associated eonveyors and spouting will be kept free from insect infestation by the employment of manual cleaning. This manual cleaning shall be supplemented at regular thrervals by the employment of such special disinfestation and eleansing measures as may be prescribed by the Director-General, Medical Services.

5. <u>Inspection</u>. All consignment of dal moong shall be inspected by an officer acting on behalf of the Director of Supplies and Transport before the dispatch of such consignments from the Military Grain Depot This inspection will be carried out after the consignment has been cleaned or otherwise treated and rebagged, and after reconditioning, if such treatment has been recommended by the inspecting officer.
